

Welcome Bonus

Terms and Conditions

1. Welcome Bonus is offered by Goget Holding Ltd (herein "the Company" of "GoGetCrypto") to the Company's clients.
2. By entering this program, the Client acknowledges that he has read, understands and agrees to be bound by these "Welcome Bonus Terms and Conditions" as well as by the "Client Agreement".
3. Client is required to deposit at least 100 USD as an initial deposit into his trading account to take advantage of "Welcome Bonus".
4. After Clients account approval and depositing the funds into GoGetCrypto Clients trading account, the Welcome Bonus relevant amount will be assigned to the Client's trading account.
5. The funds attached to the trading account as Welcome Bonus are available to increase the trading funds available and help in leveraging the account.
6. Welcome Bonus is treated as a tradable bonus amount so it may be lost but not withdraw. In case of loss on trade/trades it is deducted Client's deposit, then if loss is higher than initial deposit the loss will be covered from Welcome Bonus amount.
7. To receive the Welcome Bonus Client has to complete process of registration trading account via GoGet Crypto website only and deliver all required documents.
8. The promotional period for 30% Welcome Bonus will run from 01.09.2018 till 30.11.2018 UTC+3.
9. The Welcome Bonus applies on every deposits of a minimum 100 USD or equivalent if account base currency is different than USD. Example: 100USD deposited, Client will get 30USD as a Welcome Bonus.
10. The maximum amount that can be active in Welcome Bonus promotion is 10,000USD in total per each Client. If a Client has multiple trading accounts with GoGetCrypto, then the sum of the active bonus awarded for all of the Client's trading accounts cannot exceed 10,000 USD.
11. When a Client makes a withdrawal from her/his trading account, she/he will be subject to a proportionate removal of the bonus amount awarded. The formula used in this system is: $WITHDRAWAL\ AMOUNT \times \% \text{ of Welcome Bonus}$ () Example : If a Client withdraws 100 USD from the account, 30 USD will be subtracted automatically from the Welcome Bonus amount.
12. Internal funds transferred between trading accounts within the Company are considered as withdrawals.
13. The Company is not responsible for any consequences of the bonus cancellation, including, but not limited to, order(s) closure by Stop Out.
14. The Company reserves the right to modify or terminate this promotion at its unique discretion, and at any time without prior notice.
15. The Company has the right to decline offering of the Welcome Bonus without providing the justification.
16. If the Company suspects that a Client has abused or attempted to abuse a promotion, then the Company has the right to refuse, withhold or withdraw from that Client the Deposit Match Bonus and, if necessary, to cancel any terms and conditions with respect to that Client, either temporarily or permanently, or revoke that Client's access to the service and/or block that Client's Account.
